

Squadra Creators Program Terms and Conditions

1. Introduction

If you (hereinafter referred to as the "Applicant") are applying for the "Squadra Creators Program" (the "Program"), a content creator program for "DRAGON BALL GEKISHIN SQUADRA" (the "Game") operated by BANDAI NAMCO Entertainment Inc. (hereinafter referred to as the "Company"), please read the following carefully and agree to the Terms and Conditions of the Program before submitting your application.

By applying to participate in the Program, Applicants are deemed to have agreed to the Terms and Conditions.

2. Purpose of the Program

The purpose of the Program is to support creators certified as "Squadra Creators" (hereinafter referred to as "Certified Creators") and grow together with the fan community.

A. Application Requirements

- i. Applicants must have their own channel or account on the designated video streaming platforms specified by our company, namely, YouTube, Twitch, TikTok, OPEN REC.tv, Mirrativ (hereinafter referred to as the "Approved Platform") and provide such account information to the Company.
- ii. The Applicant's account provided to the Company must have at least 1,000 subscribers/followers.
- iii. If the application is accepted by the Company, The Applicant must be willing to continuously post contents of the Game. The Company expects Certified Creators to post videos or live-stream videos related to the Game at least 4 times a month. F

failure to meet this standard for two consecutive months will result in revocation of the Certified Creator status.

iv. Applicants must agree to abide by this Terms and Conditions, the [Squadra Creators' Guideline](#) (hereinafter referred to as the "Guideline"), and the [Terms and Conditions](#) for the games separately established by the Company.

v. Applicants must comply with the terms of use of the video platform on which the creator's activities are conducted.

vi. Applicants must be of the age of majority in the country or region where the Applicant resides.

vii. As the Program only provides support in English and Japanese, Applicants must be able to communicate in Japanese or English.

B. Support Contents

Certified Creators are entitled to the following support:

- i. Receive an invitation to access the exclusive Discord server only for the Certified Creators.
- ii. Receive the "Squadra Creators" title for the Game's official Discord server.
- iii. Receive permission to post in the streamer announcement channel of the Game's official Discord server.
- iv. Receive Official asset packs (logos, art, etc.) that can be used for content creation.
- v. Receive authorization from Company to host watch parties for official broadcasts designated by the Company.
- vi. Receive early access to updates relating to the Game.

In addition, the following additional support may be provided to Certified Creators who meet specific criteria set by the Company.

- i. Opportunities to play new Game contents in advance.
- ii. Participate in the Q&A sessions with the team from the Company.
- iii. Permission to offer specific special promotions through your channel in the Approved Platform.

iv. Introduction of the contents on the Game's official SNS accounts and other platforms.

***Criteria for additional support will be set for each category based on the average number of video views in the previous month, and it will be presented to Certified Creators by the Company.**

***Support contents are subject to change without notice.**

C. How to Apply and Flow of Application

i. Application: Applicants must fill out the required information in the Company's designated application form (as specified in the application) and submit such application.

ii. Screening: Applicants will be screened for compliance with the Application Requirements, as well as the Terms and Conditions.

iii. Notification of results: The Company will notify the results of the screening to the Applicant.

iv. Signing the Squadra Creators Program Consent Form: If your application is accepted, the Applicant will receive the Squadra Creators Program Consent Form ("Consent Form") which must be reviewed, signed and returned to the Company.

v. Start of support: After the signed Consent Form is returned to the Company, the Company will officially start support.

***The Company cannot respond to inquiries regarding the details of the screening process or the reasons for the screening results.**

D. Start Date

The approval date is defined the date when the signed Consent Form is returned to the Company.

The evaluation of the number of monthly videos posted or streamed under the Program will begin on the first day of the month following the month in which the approval date falls (hereinafter referred to as the "Start Date").

Only activities after the Start Date will be considered as an activity required as a Certified Creator.

3. The rights of the Company

A. Regarding the rights of the assets

All rights, including but not limited to all forms of IP rights in all elements of the service and assets provided by the Company to Certified Creators remains with the Company.

B. Permission to Use Content and Streaming Created by Certified Creators

Certified Creators agree that the Company may use, copy, edit, distribute, and publish for any reason, worldwide, in perpetuity and without compensation. Certified Creators also agree to provide the Company with any data, including but not limited to video and still images, that the Company may request.

4. Prohibitions

Certified Creators shall not engage in any of the following acts. If the Company deems that any of the following applies to the Certified Creators, the Company may revoke their certification. Additionally, any content containing prohibited acts shall be deleted.

- Violating the Terms and Conditions, the Guideline, or the Terms of Use of the Game.
- Disclosing or disseminating any unofficial or unreleased information that has not been provided in advance by the Company for this Program.
- Disclosing, sharing, or spreading altered data of this Game (such as unauthorized tools or MODs)

- Infringing the copyrights, trademarks, or other intellectual property rights of any third party, this includes the unauthorized creation, sale, or distribution of goods which include third party intellectual property rights.
- Any act that damages the image of "Dragon Ball" and the games offered by the Company, including but not limited to the Game.
- Disclosing communications with the Company related to this Program or the information limited to the Certified Creators without authorization from the Company.
- Creating and distributing content that combines the Game with services provided by third parties.
- Selling or transferring the benefits obtained through this Program to a third party.
- Causing or threatening to cause hassle, disadvantage, or damage to the Company, other stakeholders, or other third parties.
- Impersonating a third party or misrepresenting your identity to participate in this Program.
- Using or providing or distributing harmful programs such as computer viruses through or in relation to the Program.
- Acts that insult, slander, defame, or injure the reputation of others, or acts that have the potential to do so.
- Acts that are obscene, cruel, or discriminatory.
- Acts that violate laws and regulations or are offensive to social norms and public order and morals.
- Acts that damage or may damage the credibility of the Program
- Other acts that the Company and its affiliates deem inappropriate.

The Company will use personal information provided by Applicants for this Program only to the extent necessary for the operation of this Program, and will not disclose such information to any third party.
